No Entry level is offered at this show. All riders must be classified, though are permitted to show below their classification grade if showing *hors concours*.

**Entries *must* Include:**

1. Completed **Entry Form** and **Waiver** *must* be signed by all riders
2. **Horse insurance** is the responsibility of owner and **PROOF** in writing of comprehensive liability insurance must be included.
3. A copy of current **IPEC Classification**
4. **Copy of current memberships:** EC Gold Level member, OEF and OnTRA.
5. Para Equestrian Canada member number *if* requiring qualifying scores.
6. **Rider Bio** -include a short 'Rider Bio' i.e. years riding / competition history/ horse info.

7. *If* requesting **stabling include stabling form** and provide
  - proof of negative Coggins Test** (within 12 months).
  - cheque** for stabling made out to CARD.
8. *If* requesting a borrowed horse provide **Horse Request Form** and **cheque** for stabling made out to CARD. Borrowed horse fee to be paid to CARD.

Payment: Make cheques for stabling and borrowed horses payable to **CARD**.  
Stabling fee is *non refundable*.

**GENERAL RULES AND REGULATIONS**

**ENTRIES** – Entries will not be accepted unless accompanied by:

- 1) Your accurate and complete entry form signed waiver
- 2) All competitors must be a current OnTRA member.
- 3) Any rider(s) entering any class at this horse show **MUST** be current members in good standing of the Ontario Equestrian Federation (OEF) and EC and must supply original or photocopy of their 2010 membership before they will be issued a number.
- 4) **AWARDS** -
  - RIBBONS - awarded to 6<sup>th</sup> place. There is no prize money.
  - Riders *must be classified* and ride in the grade to which they have been assigned *or* must ride 'Hors Concours'.
  - 'Hors Concours' entrants are eligible for participation ribbon only.
- 5) **FREESTYLE MUSIC** – **Must be submitted when competitor package is picked up and on CD.**
- 6) Total entries limited to 25.
- 7) In order to attain *qualifying* National scores include a copy of *Para Equestrian Canada* membership.
- 8) Open dressage classes are covered by the rules of current FEI Para Equestrian and EC rules. Para Equestrian tests and rules can be found on the website at [www.fei.org](http://www.fei.org)
- 9) All riders must be suitably attired with an ASTM approved helmet: Competitors must wear proper fitting headgear with the safety harness correctly secured at all times while mounted on the event grounds. Boots/shoes with a heel are required.
- 10) The Show Committee reserves the right to deny riders competing if not safely attired.
- 11) **Warm up will be available as posted.** Warm up will be in the indoor arena. Please ensure that you wear your competition number at all times.
- 12) **INSURANCE** – All owners and competitors are personally responsible for damages to third parties caused by themselves, their employees, their agents or their horses. Third party insurance providing full coverage for participation in equestrian events is necessary.
- 13) Dressage Tests – Grade 1 to 4 tests will be conducted in a 20m x 40m ring
- 14) **STABLING** – The cost per stall is \$40.00 per day or part thereof for the competition on Sunday. Fee includes first bedding all other is the responsibility of the competitor.
- 15) If requesting stabling, a photocopy of a current 2010 Coggins Test is required.
- 16) **Stabling form** if stabling is required with your cheque, made payable to: CARD.
- 17) **PARKING** – Vehicles must be parked in designated areas only. Please do not park in the entrance area.
- 18) **DRUG TESTING** – EC/FEI Drug and Medications rules apply at these shows. Any horse entered in any class at any competition subject to the requirement to pay drug-testing fees may, while on the competition grounds and on the recommendation of the chair of the provincial Equine Medications Control committee or the chair's appointee, be selected for equine medication control testing.
- 19) No stallions are permitted.
- 20) No dogs allowed at the show.
